Public Relations Section Bylaws of the Joint Use/Research Center for Radiation Disaster Medical Science

**(Intent)**

ARTICLE 1:

These Bylaws stipulate the necessary items with regard to the Public Relations Section of the Joint Usage/Research Center for Radiation Disaster Medical Science (hereinafter referred to as the "SECTION") pursuant to Article 8, Paragraph 2 (established February 17, 2016) of the Internal Operational Regulations of the Joint Usage/Research Center for Radiation Disaster Medical Science.

**(Organization)**

ARTICLE 2:

The SECTION shall be composed of the following section members:

- (1) Two professors or associate professors recommended by each research institute and the Center;
  - (2) Small number of other people the Director of the Center Headquarters deems necessary.
2. The section members shall be commissioned by the Director of the Center Headquarters.
  3. The term of appointment of the section members shall be two years, and the usual practice shall be that they be commissioned on April 1. However, in the event they are commissioned on or after April 2, their final day shall be the last day of the fiscal year in which one year from the day of their commission falls.
  4. There shall be nothing to preclude the reappointment of the section members.

**(Deliberation Items)**

ARTICLE 3:

The SECTION shall deliberate on the following items:

- (1) Matters relating to the website;
- (2) Matters relating to the newsletter;
- (3) Other matters relating to public relations.

**(Meetings)**

ARTICLE 4:

The Head of the SECTION shall be appointed for the SECTION.

2. The Head of the SECTION shall be elected by mutual vote from among the section members in Article 2, Paragraph 1, Item 1.
3. The Head of the SECTION shall convene the SECTION meetings.
4. The Head of the SECTION shall be the Chairman of the SECTION meetings.
5. In the event the Head of the SECTION becomes incapacitated, committee members designated in advance shall take over his/her duties in their stead.

**(Hearing of Opinions)**

ARTICLE 5:

When deemed necessary, the SECTION may call for persons other than section members to attend meetings and hear their opinions.

**(Administrative Work)**

ARTICLE 6:

The administrative work of the SECTION shall be conducted at the Kasumi Campus Management Support Office at Hiroshima University.

**(Miscellaneous Provisions)**

ARTICLE 7:

Other items not stipulated in these Bylaws necessary with regard to the SECTION shall be decided upon separately by the SECTION.

**Supplementary Provision**

These Bylaws shall come into force as of April 1, 2016.

**Supplementary Provision**

These Bylaws shall come into force as of June 9, 2017.
